


Huntingburg is “A City Like No Other!” We need your help to make Huntingburg A **Stellar** City Like No Other! Make no mistake, we will do everything in our power to become **Stellar**. Our **Stellar** proposal includes focused projects that will have a regional impact, provide connectivity for the community, have a comprehensive long-term impact, provide sustainable viability for Huntingburg and the region, leverage private and public resources to match state and federal funding and have an immediate and lasting visual impact. These projects dovetail well with projects already underway and will provide a springboard for future projects and investment. All of these developments will light the fuse for Huntingburg, Dubois County, and our region to be ready for explosive economic success.

Huntingburg City officials aren't in this alone. The benefits of the Stellar Communities program have already had positive impact on Huntingburg. We conducted “Reviving The Pride” listening sessions, we updated our Comprehensive Plan, and we completed an OCRA funded Downtown Revitalization Plan. These all prepared us to submit our Letter of Interest for the Stellar Communities Program. The initiatives and projects identified address critical issues in our community and take advantage of opportunities to help prepare Huntingburg for the next 50 years. We haven't sat on our laurels. Partnering with INDOT, a railroad overpass project, which will link north and south Huntingburg for the first time in its history, is in the beginning stages, and is the catalyst for all of our Stellar projects. And with approved tax credits from IHCDA, the first phase of redevelopment of former St. Joseph Hospital, which has been vacant for seven years, will start before years end.

Based on our listening sessions, Comprehensive Plan update and Downtown Revitalization plan, our Strategic Investment Plan has been carefully formulated to have an exponential impact on concentrated areas of Huntingburg. This action plan is the culmination of extensive community planning and is the natural progression to implement ventures that address community and regional needs. 

## Project Outcomes & Impact

### STELLAR OUTCOMES

The City of Huntingburg has identified the following outcomes that will result from the Stellar activities:

#### 1.2 St. Joseph Hospital Campus Redevelopment

- Activates a derelict building in the core of northside residential district
- Puts a significant property back on the tax roles
- Revitalizes the northside business district
- Meets a critical need for affordable senior housing

#### 1.3 Senior Center

- Provides a larger facility to meet the needs of a growing senior population
- Is ideally located near senior housing projects and the Heritage Trail
- Allows for enhanced use of the Old Town Hall, the current location of the Senior Center

#### 2 Heritage Trail

- Links key elements, including the Veterans Monument, to the community
- Provides recreation opportunity for all age groups, regardless of physical ability
- Connects neighborhoods to schools and businesses
- Provides for aging in place
- Promotes healthy communities
- Reduces vehicular traffic
- Adds a key component to our quality of life

#### 3 Maintenance / Emergency Shelter

- Relocates existing facility out of floodplain
- Moves salt storage and other hazardous materials out of the floodway
- Relocates facility to area of comparable land use and in the heart of our highest daytime workforce
- Serves as emergency shelter
- Serves as training facility for emergency and public safety personnel
- Serves as a secondary command center for the Dubois County EMA

#### 4 Community Gateways

- Creates gateways welcoming visitors and residents
- Provides branding opportunity for Huntingburg
- Develops an inviting and welcoming atmosphere

#### 5 9th Street Extension

- Provides a safe connection to the industrial property to the north and west of the Norfolk and Southern Railroad
- Is essential to the success of the Overpass Project by providing critical circulation while the project is under construction
- Allows for the expansion of the Industrial Park, including OFS Brands and Touch of Class, two of our community partners

#### 6 14th Street Reconstruction

- Is needed to handle heavy truck and additional traffic expected when the Overpass Project is complete
- Provides a key pedestrian and vehicular connection to the Overpass Project and US 231

- Enhances the use of Huntingburg Event and Community Center
- As part of the Heritage Trail, connects the Event and Community Center and Veterans Monument to the east side of Huntingburg and the St. Joseph Hospital Redevelopment Project
- Enhances the development of the 14th Street Hospitality Corridor identified in the Comprehensive Plan

#### 7 4th and Market Street Park

- Connects 4th Street and Market Street
- Creates space in the heart of downtown for events and activities
- Makes Market Street a community gathering point
- Promotes increased use of the city icon, Old Town Hall

#### 8 4th Street Water Main Replacement

- Provides reliable fire protection
- Provides opportunity for new development
- Provides opportunity for new investment
- Provides reliable city services

#### 9 Workforce Housing

- Meets critical need for workforce housing for both apartments and first time home buyers
- Promotes workforce growth
- Grows tax base
- Develops property within corporate limits which minimizes extension of infrastructure
- Translates to a \$17.2 to \$20.8 million in private investment

## Project Outcomes & Impact

Completion of the Stellar projects will be the first major step forward for Huntingburg's revitalization efforts, but not the last. The Stellar Communities Program lays the groundwork for our future, and we have identified a number of complementary projects that will be pursued after the four year Stellar funding cycle is finished. We will tackle these complimentary projects, and each of the opportunities identified in our Comprehensive and Downtown Revitalization Plans, with the same energy and commitment we have made for the Stellar program. We know that investment draws investment. By aggressively completing the Stellar projects and moving on to the complimentary projects, we will attract new residents and new investment to Huntingburg and Dubois County.

### STELLAR IMPACTS

The Stellar projects have been selected for their ability to transform and connect Huntingburg and drive economic investment. These projects will have a dramatic visible and aesthetic impact on Huntingburg and will stimulate new and existing business growth and provide incentive for new investment in the region.

**Huntingburg and Dubois County** are economic engines for Indiana. With the second lowest unemployment rate in Indiana at 4.4%, Huntingburg and Dubois County are essentially at full employment. With the recently announced growth of our successful companies, the challenge is filling those jobs locally. Because of a housing shortage, the majority of new positions will be filled by outside of the county. We must implement a cohesive strategy that helps our workforce and youth obtain the skills they need to meet this critical need. Working with Vincennes University-Jasper, WorkOne Southwest and Radius

Indiana is critical. Huntingburg is known for our manufacturing, which has economic impacts at the local, regional, national, and international levels. Our Stellar Projects will provide vital infrastructure (homes and quality of life) our regional industries expect by fulfilling critical workforce needs in the Radius Indiana region.

### Industry

**OFS Huntingburg** - Huntingburg-based OFS Brands is the parent company for OFS, First Office, Carolina, Loewenstein, and Styline Logistics, all working together to create a better future. OFS Brands is a company whose history is steeped in the rich furniture making tradition and strong German heritage of southern Indiana. They have been crafting fine wood furniture in Huntingburg for over 75 years. Today, their operations include seven manufacturing plants and four support plants responsible for millions of dollars in production. OFS is the largest employer in Huntingburg with 1,700 employees that produce products sold around the world.

**Jasper Engines and Transmissions** - Jasper Engines and Transmissions (JET) has been remanufacturing quality products since 1942 and today is the nation's largest remanufacturer of gas and diesel engines, transmissions, differentials, rear axle assemblies, marine engines, stern drives, performance engines, and electric motors. JET has over 1,700 Associates (132 who reside in Huntingburg) and 41 branch and distributor locations.

On April 30, 2014, Jasper Engine and Transmission announced the creation of 235 jobs by 2017. They plan to expand its local footprint to create jobs and reinvest in the former Kimball Plastics manufacturing

facility. The company plans to invest \$6.9 million to renovate and equip a 220,000-square-foot facility that is currently vacant.

**MasterBrands** - MasterBrand Cabinets, Inc. (MBCI), a manufacturer of home cabinetry products, announced in January of 2014 135 new jobs by June of 2014 and in April of 2014 announced another 262 jobs by the end of 2016 for a total of 397 new jobs.

The Jasper-headquartered company will invest approximately \$8 million in equipment that will add additional capacity and expand the product offering at its 500,000 square-foot facility located in Ferdinand. MBCI, which currently employs more than 3,500 associates at its six Indiana facilities and more than 1,500 in Ferdinand, plans to begin hiring cabinet assemblers, component pullers, shipping helpers, supervision and quality positions later this year. MBCI's Huntingburg facility is the primary supplier of product for the Ferdinand assembly plant.

### Region

According to Dubois Strong, the recently announced 632 jobs in Dubois County will generate over \$51 million in new wages, with an average earnings per job of \$53,211, and create an additional 333 indirect jobs. These jobs will provide new income tax, growing the local EDIT funds, and the new development will enhance the property tax base.

**Radius Indiana's** - Radius Indiana's mission is to lead regional collaboration by leveraging the diverse assets of Southern Indiana to drive attraction, retention and expansion of business, thereby increasing employment and investment opportunities and quality of life within the region. Radius Indiana's four main sectors are Defense, Tourism, Manufacturing, and Education. This regional partnership of counties is under the leadership of former Lt. Governor Becky Skillman. Formed in 2009, Radius Indiana serves as a primary point of contact in Indiana for NSWC Crane Division.

**Vincennes University-Jasper Campus** - The Vincennes University-Jasper Campus and seven local manufacturing companies have joined forces in a partnership to address a major workforce challenge. Employers have reported that their greatest need is for technicians with the skills to maintain and program high-tech equipment such as CNC machines, laser cutters, industrial robots and electronic controls.

The partnership has created an associate degree program in Technical Maintenance in which students will be employed part-time and enrolled at VUJC full-time. Graduates of this program are in high demand by industry both locally and nationally. The students' work assignments will be coordinated with their on-campus classroom and lab experiences. The employers will assign a senior technician as mentor to each student. At the end of their studies, those enrolled will have earned an associate degree, have two years of work experience, receive preferred employment with their companies in a stimulating and satisfying career field, and will have no student debt. Employers in the degree partnership include Jasper Engines and Transmissions; Indiana Furniture Industries (IFI); OFS Brands; Wabash Valley Produce, MasterBrand Cabinets; Kimball International; Kimball Electronics; Kimball Office; and Jasper Rubber. The program will be offered at the new Center for Technology, Innovation, and Manufacturing on the VUJC campus.

### Local

Of the 2,492 housing units available in Huntingburg only 43 are for sale. That means only 1.7% of the housing stock available in the City. According to the national averages, having 4.1% available for sale is considered a healthy market. The Martin Group will provide an initial 35 units in the first phase and 40 in the second phase of a multi-family development for a total investment of \$8.5 million. As the result of the interest created by Huntingburg being a named a Stellar Community Finalist and the clear need for workforce housing in Dubois County, Boxer Girl, LLC has become a partner that will develop as many as 80 detached, for sale, workforce housing units. This is a new development since the letter of interest was submitted. With price points between \$100K to \$120K per unit, this represents another private investment of \$8M to \$10M.

# Strategic Investment Plan: PROJECT COSTS & AMOUNT REQUEST

The project mix of Huntingburg's Stellar Strategic Investment Plan aligns well with the priorities and funding sources of INDOT, IHCDA, and OCRA. The projects also address critical issues in Huntingburg that facilitate leveraging local resources to complete those projects that need to be funded locally. Our project budget clearly shows that each and every project is financially feasible. A Preliminary Tax Increment Finance (TIF) Analysis prepared by Crowe Horwath, LLP verifies our ability to meet the financial commitments of this aggressive plan. The estimated cost of Huntingburg's Stellar projects is \$42,500,000. Of this total, \$33,200,000 will come from leveraged resources. Because of Huntingburg's sound financial management and the partnerships Huntingburg has forged with the Dubois County government, the Dubois County Community Foundation and private industry partners, Huntingburg will provide nearly a 4:1 dollar match to State funds.

To meet the demand for senior and affordable workforce housing, private developers have committed to over \$25,000,000 for planned housing projects in the Stellar Impact Zone. The Huntingburg City Council has approved a resolution committing \$500,000 in Economic Development Income Tax (EDIT) funds in support of the Stellar proposal. The Dubois County Commissioners and County Council have designated \$500,000 in county EDIT funds toward Huntingburg's Stellar Proposal over the next four years. In partnership with Dubois County Community Foundation, a \$1.8 million fund-raising campaign will be launched in support of our Stellar designation. Of that fund, 60% will be earmarked for immediate use, with 40% to be placed in an endowment to maintain the projects and provide long-term sustainability. The Foundation recently announced their largest single grant of \$50,000 toward our Stellar projects. An additional \$530,000 has been pledged to the Foundation when Huntingburg receives the Stellar designation. And the Foundation's public effort to gain support for the Stellar program has yet to begin.

### PLANNING PROCESS

Under the leadership of the Huntingburg City Council, three major planning initiatives were completed over the last two and a half years. Each of these efforts was to actively engage the community and identify issues and opportunities and lay the course for Huntingburg's future.

#### “Reviving the Pride” Vision

- **Community Place** - The various places that makeup a community: where we live, shop, work, recreate, learn, worship, and gather create a quality of life. How these various land uses function together, how they look, and how the residents feel about these places creates the “sense of community.”
- **Community Connections** - A complete trail system would provide preventive health-care benefits, attract eco and recreational tourists, address safety concerns for school children, and enhance economic opportunities. Such trails are generating significant economic impacts in communities across the nation.
- **Community Identity** - Attention to entrances on key corridors should be given strong consideration. New entry features should be constructed at both ends of the proposed Railroad Overpass. The intersection at US 231 and SR 64 should be developed as the major entry feature to the city, identifying the arrival to downtown.
- **Community Opportunity** – Key community elements were identified that when properly addressed, should be building blocks for an effective strategic economic approach to strengthening the community. These specific assets include:
  - Downtown
  - Huntingburg Regional Airport
  - Railroad Overpass
  - Events and Community Center / St. Joseph's Hospital Area
  - Huntingburg League Stadium

#### Downtown Revitalization Plan Goals

An OCRA funded Downtown Revitalization Plan was completed in 2013, focusing on our Historic 4th Street. As a result, we have a clearly defined set of goals for the heart of Huntingburg.

- Create “WIN-WIN” scenarios for Huntingburg's largest employers and downtown by encouraging them to participate in and support the revitalization of 4th Street.
- Establish downtown as the next great neighborhood in Huntingburg by creating additional living options through new construction and upper story renovations.
- Build off Huntingburg's position as a regional destination for shopping, dining, and entertainment to expand downtown's customer base.
- Create new employment opportunities and attract regional employees to downtown with vibrant retail, dining, and entertainment options as well as diverse housing opportunities for all income levels.

#### Comprehensive Plan Growth Objectives

An update of the 2007 Comprehensive Plan, also completed in 2013, identified city wide issues and areas where Huntingburg will need to experience growth in order to remain a vibrant, attractive community.

- **Residential Base** - Increase the number of people who live in and have access to downtown will ensure around-the-clock activity, expand the built-in customer base for local shops and restaurants, and increase the local tax base.
- **Public Spaces** - Formalize existing gathering and open spaces to be used by the public for events and festivals. Open space is an important factor in increasing the quality of life for residents, employees, and visitors, while at the same time diversifying its ability to support different activities.
- **Visitor Impact** - Continue to expand and diversify events and programming to attract visitors as repeat supporters of local shops and restaurants.
- **Infrastructure** - Replacement of the water line along 4th Street is a well-known need, but improvements to sidewalks, parking configurations, and improved landscaping and lighting will enhance and unify the look of the city.
- **Connectivity** - Create additional access by connecting existing recreational destinations and public spaces along an urban trail system. Trails through urban areas are known to increase property values and spending.

As our application clearly shows, the planning efforts put forth by the City Council over the past two years are addressed in our Stellar projects.

### SUPPORTING OUR RESIDENTS & VISITORS

The City of Huntingburg, its residents, businesses and partners have identified a number of projects that will have a dramatic impact on Huntingburg, Dubois County, the Radius Indiana region and the State of Indiana. Huntingburg is ready to implement these projects that will reap benefits for a wide array of stakeholders.

**Workforce:** To attract the workforce necessary to fill the 600 + new jobs being created in Dubois County, we need quality of life amenities, reliable infrastructure and housing at an affordable price point. By providing both apartments and detached housing we offer a mix of options that meet the needs and desires of each family.

**Senior Citizens:** The Lofts at St. Joseph's Apartments, the new Senior Center and the proximity of business and services in the immediate vicinity makes the former St. Joseph Hospital an attractive site for seniors. The addition of the Heritage Trail will create a walkable community that will encourage them to visit and travel throughout the neighborhood and other areas of the community that are connected via the trail system.

**Youth:** The youth in our community play a significant role in the future of Huntingburg. Organizations such as: A Kid's Place, a community daycare that serves for over 130 local children; Southwest Dubois School Corporation, providing quality education for over 1,700 students; and the Teen Outback, a local non-profit youth organization housed in a 10,000 square ft. facility that offers after-school, all-day summer and weekend programs, are able to provide care and education from infancy through high school.

**Young Entrepreneurs:** While Huntingburg was once experiencing the effects of the "brain drain" epidemic, we're seeing an upward shift in the number of young professionals moving back to the area after college. In fact, we currently have five business owners on 4th Street who are age 32 and under. There is still much to be done to provide quality, affordable housing; offer better amenities and improve the overall quality of life needed to attract more of our youth back to Huntingburg.

**Tourists & Visitors:** By reinforcing the fabric of Historic Downtown Huntingburg and making it a pedestrian friendly space; providing venues for events and activities that attract a broad spectrum of visitors; and having a greater variety of festivals and special events, 4th Street will become a true destination for the thousands of tourists and visitors that frequent Southwestern Indiana.

**Arts & Culture Community:** The 4th and Market Street Park will have the most direct impact on local Arts and Culture. This will provide an attractive location for a wide range of events and activities. This space will provide a venue for our area's only Hispanic Festival, the annual Garden Gate Jazz, Art, Wine and Craft Beer Festival, the Farmer's Market, Haunted Huntingburg and other downtown events. These events currently attract over 5,000 people to downtown Huntingburg.

The Dubois County Community Foundation provided a two-year grant to launch our Artworks Initiative for arts and culture. The grant to the American Latin Association of Southern Indiana helped celebrate the presence of the Hispanic Culture and the Latino Community in our region.

**Downtown Businesses:** By providing a new waterline, bringing the Heritage Trail through the heart of downtown, creating a user-friendly flexible space that can be adaptable for the business owner and making improvements to Fourth and Market Street Park, we are making downtown Huntingburg a hub of activity which will provide significant customer traffic for those who make a business investment in the heart of our community.



**Professionals:** All of the activities Huntingburg is working on are with the goal of building on the high quality of life in Huntingburg. By addressing issues in the community and adding a number of amenities, this will give Huntingburg an advantage in being able to attract not only the workforce but those professionals that are critical to the success of a community.

**Health & Wellness Advocates:** Working to make Huntingburg a walkable and biking community will provide a great resource for our residents to use a safe and accessible trail. This single action will directly affect all citizens regardless of age or ability. This will also tie into our "5-5-5" program of free 5K's that promote physical activity and community spirit. As Wellness Advocates, we are helping to set an example as our initiatives have been recognized by the American Heart Association, naming the City of Huntingburg as a Gold Fit Friendly Workplace.

**Defense & Military:** Huntingburg is the only community in the Crane Naval Surface Warfare Center area and the Radius Indiana

region participating in the 2014 Stellar program. After talking with the Commander of NSWC Crane, it became clear that with the Stellar designation, Huntingburg could position itself as a major asset for Crane as it works to attract the best and brightest to the 4th largest concentration of scientists and engineers in the country. As the Colonel said "We need to surround ourselves with Stellar Communities" because that is the kind of place he wants his workforce to live.

**Filmmakers:** Huntingburg has already been the location for three major motion pictures (A League of Their Own, Soul of the Game and Hard Rain). Huntingburg's quality of life has been enhanced by the film industry, with League Stadium being a major recreation and community gathering spot. We will use our experience as a springboard to create an office for the promotion of the movie industry not just in Huntingburg, but across the State of Indiana.



## SENIOR HOSPITAL REDEVELOPMENT



### Stellar Activities

The campus of the former St. Joseph's Hospital will be revitalized in three ways:

#### 1. Senior Living Apartments:

- The north and west wings of the main building will become independent living senior housing for residents 55 and over
- Over 30,000 square feet will be renovated into 25 one and two bedroom apartments
- A 27,000 square foot addition will be constructed on the north side to provide an additional 20 units

## HERITAGE TRAIL



### Stellar Activities







Information related to Stellar activities and their implementation will be made available to the public by **Communications Director Rachel Steckler** through the City's website and social media outlets and by periodic press releases on Stellar updates and information. **Mayor Denny Spinner** will conduct monthly Stellar progress meetings with City department heads and the local steering committee. Huntingburg will host quarterly meetings with OCRA, INDOT, and IHCD to keep the agencies abreast of progress being made.
