## BOARD OF PUBLIC WORKS & SAFETY Thursday, April 4, 2024 8:30 A.M.

The Board of Public Works & Safety of the City of Huntingburg met in regular session on Thursday, April 4, 2024 at the hour of 8:30 A.M. in the Council Chambers of the Huntingburg City Hall. Members Fitch, Blessinger, Schmett and Souders were present. Also present were Clerk-Treasurer Dippel and City Attorney Schneider. Member Elkins was absent.

Due to Mayor Elkins' absence for training, the meeting was called to order by member Blessinger.

A motion was made by Fitch, seconded by Souders and carried to elect member Blessinger, Temporary Chairman, in the Mayors absence, to run the meeting.

A motion was made by Schmett, seconded by Souders and carried to approve the minutes of the March 7, 2024 regular meeting and the March 20, 2024 Special meeting.

A motion was made by Fitch, seconded by Souders and carried to approve the claims for payment as presented.

Street Superintendent Stamm presented the monthly Street Department report. He informed the Board that St. Mary's Church is looking to do improvements in their parking lot and would like the City to look into closing the alley at the north of their property. Attorney Schneider will look into the platting of the area.
