

ADVERTISEMENT FOR BIDS

Separate sealed BIDS for the Reconstruction of a portion of Geiger Street (10th St. – 11th St.) and 10th Street (Geiger St. to 280-LF West of US 231) will be received by the City of Huntingburg Board of Public Works and Safety at the Huntingburg Clerk-Treasures Office located at 508 E. Fourth Street, Huntingburg, IN 47542 until 9:00 a.m. (local time) February 3, 2025, and then at 9:00 a.m. (local time) February 3, 2025, publicly opened and read aloud in the Council Chambers of the City Office Building. Bids received after 9:00 a.m. (local time) on February 3, 2025 will be returned unopened. Each Bid must be enclosed in a sealed envelope bearing the title "2024-02 CCMG Project #1" and the name and address of Bidder.

The project consists of removing and replacing of a portion of the existing concrete roadway and curb/gutter, and also storm sewer system replacement.

The OWNER reserves the right to waive any informality or to reject any and all bids. Award will be made to the low, responsive, responsible bidder. No proposal may be withdrawn after the scheduled closing time for receipt of bids for at least sixty (60) days. A conditional or qualified bid will not be accepted.

Each BIDDER must deposit with his bid, a certified check or acceptable bidder's bond made payable to the owner, in a sum not less than five percent (5%) of the total amount of the bid. This check or bond will be held by the owner as evidence that the bidder will, if awarded the contract, enter into the same with the owner upon notification from him to do so within ten (10) days of said notification.

Contractor receiving award shall furnish an approved Performance Bond and Payment Bond, if contract is \$200,000 or greater, in an amount at least equal to 100% of the contract amount and must be in full force and effect throughout the term of the construction project plus a period of twelve (12) months from the date of the substantial completion. Bonds shall be furnished at time of notice to proceed of contract.

Each BIDDER must complete and submit with BID Indiana Form 96 inclusive of Non-Collusion Affidavit Standard Questionnaire and Financial Statement and other required documents as required by Indiana law.

A Pre-bid conference will be held for this project on Wednesday, January 22, 2025 at 9:00 a.m. (local time) at the Council Chambers of the City Office Building located at 508 E. Fourth Street, Huntingburg, IN 47542. Bidders are encouraged attend the pre-bid conference and also to visit the proposed work areas during the bidding period. Engineer will transmit to all prospective Bidders of record such Addenda as Engineer considers necessary in response to questions arising during the bidding process. Oral statements may not be relied upon and will not be binding or legally effective.
