The Common Council and Utility Board of the City of Huntingburg met in joint session on Tuesday, August 12, 2025 at the hour of 5:30 P.M. in the Council Chambers of the Huntingburg City Hall at 508 E. Fourth Street, Huntingburg, Indiana. Members Kissling, Bolte, Bounds, Wehr and McPherron were physically present. This meeting was opened to the public, and made available to members of the public and the media streamed through the City of Huntingburg's YouTube channel accessed via the City of Huntingburg's website. Also present were Mayor Elkins, City Attorney Schneider and Deputy Clerk-Treasurer Stevens.

Mayor Elkins called the meeting to order.

A motion was made by Kissling, seconded by Bounds and carried to approve the minutes of the July 22, 2025 regular meeting.

A motion was made by Wehr, seconded by Bolte and carried to approve the claims as presented.

There was discussion on the proposed parking restrictions ordinance for streets in Hunter's Crossing subdivision. Streets discussed were Hunter's Crossing Circle, Wilson Circle and Abby Lane.

A motion was made by Wehr, seconded by McPherron and carried to introduce Ordinance No. 2025-17 entitled:

AN ORDINANCE AMENDING THE HUNTINGBURG CODE OF ORDINANCES CHAPTER 75 ADDING PARKING RESTRICTIONS ON PORTIONS OF CERTAIN DESIGNATED STREETS WITHIN THE CITY OF HUNTINGBURG

A motion was made by Kissling, seconded by Bolte and carried with unanimous consent to suspend the rules and consider the adoption of Ordinance No. 2025-17 at the same meeting it was introduced.

A motion was made by McPherron, seconded by Wehr and carried to adopt Ordinance No. 2025-17.

Upon call of roll for the adoption or rejection of Ordinance No. 2025-17 the vote being 5 ayes, 0 nays, in favor of adoption, Ordinance No. 2025-17 was duly passed and adopted this date at the hour of 5:47 P.M.

Colton Pipenger, Executive Director of Dubois Strong, was present to update the Council on Economic Development in Dubois County.

Maleah Dearing, with the Mayor's Youth Council, informed the Council on their upcoming club fair on August 22nd.

Janet Schnell addressed the Council with an update on the hoarding issues, along with vacant properties, in the City.
