



Park Board Members Present: Mike Fulkerson, Dustin Schmett, Abby Fink

1. Approval and signing of all claims. Dustin motioned to approve, Abby seconded. 3-0 approval.
2. Approval and signing of the September 16, 2019 minutes. Mike motioned to approve, Abby seconded. 3-0 approval.
3. Director's Report:
 - A. General:
 - a. Please welcome Dustin Schmett to the park board. He is replacing Mark Peters and will serve out the rest of the term.
 - b. Vote for Vice President position was put on hold until next meeting. The vacancy was because Mark Peters was the vice-president and he moved out of the area.
 - c. Discuss events in parks for next year. All events need to be approved by the park board.
 - d. The new safety director, Travis Gentry took a look at all of the park facilities and made a list of some changes and additions that the park will make. Changes and additions are being completed. Mostly signage. Exits on doors, etc. non skid stuff labeling.
 - e. Idea for 2021: Discuss possible fabric building for indoor multipurpose concrete courts. Cost of this is unsure, this was just an idea, Larry will get numbers to see if possible in the near future.
 - f. Next year we'll put up gates between buildings and tear down old fencing where the old street department was. Hoping to maximize parking for events.
 - g. Meeting with Seufert construction on pricing of screening in a shelter house Thursday the 24th. Chuck Recker will be coming to the park to discuss items about this as well.
 - B. Market Street Park:
 - a. If the tables are not under the Market Pavillion people drive through it. If tables are moved, they must be put back by users.
 - b. Haunted Huntingburg was a success.
 - c. Signs will be installed sometime in the next few weeks. We also have portable signs made for events.
 - C. Old Town Hall:

- a. The AC system has been repaired
 - D. Senior Citizens:
 - a. No new news. Rita needed to take vacation days, so she can only work 7 hours for the next 2 weeks. Larry just wanted to give us a heads up incase someone called to inquire.
 - b. Their trip to North Carolina is filled up; 40 people.
 - E. Pool:
 - a. New filtration system is installed. Some electric work and an eyewash station will have to be installed. This is a safety issue; anytime there are chemicals present, there must be eye wash station too
 - b. The plan is to enclose the filter structure some time next year. This is also to keep people out.
 - F. League Stadium:
 - a. The new sod that was installed on base paths and behind home has taken hold and looks great.
 - b. Seufert Construction has completed the repairs. Painting is now being completed.
 - G. Northside Park:
 - a. Jaminsky has started the project. The poles are in for the fencing around the court and it is ready for concrete to be poured. The swail has been dug and all drainage pipes are in place. We are going to concrete some areas in the swail to help with drainage and future upkeep.
 - H. Niehaus Park:
 - a. Tree limbs were chipped up in the woods. It has helped the Disc Golf course players and pedestrians views. Quite a few loads of mulch were donated by Mike LeClere. They were spread out for the disc golf range. Dirt was put in front of some disc golf course bridges.
 - b. Drainage pipe will be put in place by the sidewalk towards water tower. Brad Coomer the Wastewater Superintendent gave his authorization to install it.
 - I. Southside Park: Fence on the south side of the ditch will be taken down this winter.
 - J. Bark Park: No news to report
 - K. Monthly report: copies given
 - L. It was decided to put up a permanent awning for the girls softball field.
