1. Approval and signing of all claims. Shannon motioned, Dustin seconded. 4-0 approval.
2. Approval and signing of the December 16, 2019 minutes. Mike motioned, Abby seconded. 4-0 approval.
3. Director's Report:
 - A. General:
 - a. Ashley Blessinger and Mike Uebelhor of the Dubois County Bombers presented new plans for League Stadium. The current picnic area would have a partial wall enclosure and a 20 X 30 upper deck building added on behind it. Treated lumber will be used and the deck will contain a green metal roof to match the rest of the stadium. Concrete will also be extended. Seufert Construction plans to complete the project by May 1. This addition will allow groups a rental space and picnic area for Bombers games. In addition, Fischer Electric will install 12 more fans in the current stadium and 4 fans in the new addition. Mike motioned to approve the project. Dustin seconded. 4-0 approval.
 - b. Destination Huntingburg: The Ice Skating Rink event at Market Street Park took place in December. It was a success.
 - c. YMCA is going to hold exercise classes at Senior Center.
 - d. Bids for a new mower for Niehaus Park were presented by Larry. Mike motioned to approve the All Seasons bid of \$13,494. The Huntingburg City Water Department is purchasing the mower that was going to be traded for \$8000. Dustin seconded. 4-0 approval.
 - e. New gas line was installed to the east building.
 - f. Travis Gentry, the new safety director gave us a list of items to correct before summer. We are in the process of getting signage, lights, and other issues corrected. The press box at League Stadium will have new receptacles installed.
 - B. Market Street Park:
 - a. No new news
 - C. Old Town Hall:
 - a. The digital controller was ordered.
 - D. Senior Citizens:
 - a. Next trip Norfolk Virginia for the "Parade of Nations" on April 29-May 4th

- b. Attendance keeps growing.
 - E. Pool:
 - a. KWK is going to get a quote for the refinishing of the slide. The old diving board is cracked. A new diving board is \$5-6,500 depending on the type of board. The 1 meter diving structure is approximately \$9,500 plus shipping.
 - b. RG will install a water line for a wash station in the water filter building. Also some electrical work will need to be updated.
 - c. Discussed extending current filter building. May need state approval which will need approved drawings. A concrete pad will be poured between the pool house and filter building. Mike motioned to approve to have designs put together for this. Dustin seconded. 4-0 approval.
 - F. League Stadium:
 - a. The Bombers locker room was repainted, restroom partitions hung, benches repaired, and new LED lights installed.
 - b. Installed new LED lights in announcing booth
 - c. Area for concrete is dug out to prepare for pouring concrete south of the batting storage area and also under the stadium first base side.
 - G. Northside Park:
 - a. Applying for grant with Lisa Gehlhausen - Indiana 15 for trails and playground.. Meeting with playground vendors to get new drawings and ideas for the playground area.
 - b. The Mayor is having a meeting for the shelter house Jan 28 at 10:00 AM.
 - H. Niehaus Park:
 - a. The "Border Battle Indiana vs Kentucky" disc golf tournament will be held on Sunday March 8th.
 - b. The sanctioned Niehaus Disc Golf Annual Tournament will be held on April 19th.
