

NOTICE OF HEARING
PROPOSED SEWAGE WORKS RATES

Property owners, ratepayers and other interested parties in or served or to be served by the sewage works of the City of Huntingburg are hereby notified that Ordinance No. 2020-22, establishing rates and charges for services to be rendered by the sewage works, was introduced at a meeting of the Common Council held on September 8, 2020. At a meeting of the Council to be held at 5:30 o'clock P.M., on September 22, 2020, in the Council Chambers of the City Office Building, 508 E. Fourth Street, Huntingburg, Indiana, there will be a public hearing on the matter of the rates and charges, and consideration of adoption of said Ordinance No. 2020-22 which provides for the adoption of the following schedule of rates and charges:

At such hearing and prior to final adoption of said Ordinance all interested parties may appear and be heard. A copy of Ordinance No. 2020-22 may be examined at the Office of the Clerk-Treasurer, 508 E. Fourth Street, Huntingburg, Indiana.

Following the adoption of the rate Ordinance, the users of the sewage works located outside the City's corporate boundaries may be entitled to petition the Indiana Utility Regulatory Commission under I.C. 8-1.5-3-8.3 to review and adjust the rates and charges imposed on users if a petition under I.C. 8-1.5-3-8.2 or I.C. 36-9-23-26.1 with respect to the same rate ordinance has not been filed. However, please note that no surcharge applicable to users outside the corporate boundaries of the City currently exists, nor is such a surcharge proposed. Therefore, the proposed rates and charges are not subject to review by the Indiana Utility Regulatory Commission under I.C. 8-1.5-3-8.3.
