CITY OF HUNTINGBURG, INDIANA ORDINANCE NO. 2019- 17-

AN ORDINANCE CORRECTING A SCRIVENER'S ERROR IN ORDINANCE NO. 2019-06 AMENDING THE SCHEDULE OF RATES AND CHARGES FOR USE OF AND SERVICES RENDERED BY THE MUNICIPAL WATERWORKS OF THE CITY OF HUNTINGBURG, INDIANA

WHEREAS, the Common Council of the City of Huntingburg has heretofore adopted Ordinance No. 2019-06 on February 12, 2019, which Ordinance, among other things, adopted a wholesale water cost tracker in the sum of \$0.26 per one hundred (100) cubic feet to recover the increased cost of purchased water; and

WHEREAS, the schedule monthly metered rates for service outside the City limits included in said Ordinance No. 2019-06 incorrectly stated the application of the wholesale water cost tracker to customers served outside the City limits; and

WHEREAS, said Ordinance No. 2019-06 omitted provisions for the application of the wholesale water cost tracker to Rates for Resale; and

WHEREAS, it is necessary to amend said Ordinance No. 2019-06 to provide for the proper application of the wholesale water cost tracker to all rate categories.

NOW THEREFORE, BE IT ORDAINED by the Common Council of the City of Huntingburg, Indiana, as follows:

Section 1. Ordinance No. 2019-06 is hereby amended by correcting the monthly metered rates for service outside City limits so that same reads as follows:

Service Outside City Limits

For retail users of water located outside the corporate limits of the City of Huntingburg whose monthly usage is less than one million cubic feet per month, an amount equal to 125% of the Monthly Service Charge shall be imposed monthly, plus a monthly charge based on the quantity of water supplied as metered in accordance with the following schedule:

Monthly metered charges for retail water customers located outside the corporate limits of the City of Huntingburg whose monthly usage is more than one million cubic feet per month, shall be at the same rates as metered charges for retail water customers located inside the corporate limits of the City.

Section 2. Ordinance No. 2019-06 is hereby further amended to add thereto the following:

Rates for Resale:

A wholesale water cost tracker in the sum of \$0.26 per 100 cubic feet of water purchased shall be added to the current monthly metered rate for water supplied at each metered connection.

Section 3. This Ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.
