

**CITY OF HUNTINGBURG, INDIANA
ORDINANCE NO. 2011-28**

**AN ORDINANCE AMENDING ORDINANCE NO. 2009-36
TO ESTABLISH A NEW WATER RATE CLASSIFICATION
FOR THE SALE OF BULK TREATED WATER**

WHEREAS, the Common Council of the City of Huntingburg has heretofore adopted Ordinance No. 2009-36 establishing rates and charges for use of and services rendered by the municipally owned water utility, which rates and charges did not include a rate for the bulk sale of treated potable water delivered to a customer at the treatment plant;

WHEREAS, From time to time customers will request the bulk purchase of potable treated water to be delivered into their equipment at the City's water treatment plant; and,

WHEREAS, upon recommendation of the Utility Rate Advisory Board and the Utility Board of the City of Huntingburg, and after due notice and public hearing, the Common Council of the City of Huntingburg now finds that the water rates and charges should be amended to include a charge for the bulk sale potable treated water.

NOW THEREFORE, BE IT ORDAINED by the Common Council of the City of Huntingburg, Indiana, as follows:

Section 1. That Ordinance 2009-36 providing for a schedule of rates and charges for use of and services rendered by the municipally owned water utility is hereby amended by adding thereto the following rate classification and rate:

Bulk Water Sales:

For bulk water sales at the treatment plant, delivered into customer's equipment:


Service fee per fill	\$ 25.00
Plus	
Rate per 100 gallons purchased	\$ 0.62

Section 2. That the rates and charges hereinabove set forth for Bulk Water Sales shall become effective for service rendered after December 1, 2011,






