

UTILITY BOARD/COMMON COUNCIL

Tuesday, April 11, 2023

5:30 P.M.

The Common Council and Utility Board of the City of Huntingburg met in joint session on Tuesday, April 11, 2023 at the hour of 5:30 P.M. in the Council Chambers of the Huntingburg City Hall at 508 E. Fourth Street, Huntingburg, Indiana. Members McPherron, Kissling, Dubon, Bounds and Wehr were physically present. This meeting was opened to the public, and made available to members of the public and the media streamed through the City of Huntingburg's YouTube channel accessed via the City of Huntingburg's website. Also present were Mayor Schwinghamer, City Attorney Schneider and Clerk-Treasurer Dippel.

Mayor Schwinghamer called the meeting to order.

A motion was made by Kissling, seconded by McPherron and carried to approve the minutes of the March 28, 2023 regular meeting.

A motion was made by Wehr, seconded by Dubon and carried to approve the claims as presented.

Transit Director Blessinger presented a proposed resolution to authorize applying for the calendar year 2024 5311 Transit Grant. She estimates the Federal grant to be \$136,869.00 and the State grant to be \$25,053.00. She updated the Council on the Transit Department.

A motion was made by McPherron, seconded by Kissling and carried to adopt Resolution No. 2023-12 entitled:

Planning Director Lake presented two proposed ordinance amending zoning maps. The first would change the map at 806 E. 7th Street from R-1 to R-2. The second would change the zoning map at 906 E. 7th Street from R-1 to R-2. The changes were recommended by the Huntingburg Plan Commission.
