NOTICE IS HEREBY GIVEN that the Common Council of the City of Huntingburg will conduct a public hearing at the hour of 5:30 o'clock P.M. on the 25th day of February, 2025, at the Council Chambers of the City Office Building, 508 E. Fourth Street, Huntingburg, Indiana, prior to consideration of the adoption of Ordinance No. 2025-04, an Ordinance Amending Ordinance No. 2013-36 as amended by Ordinance 2022-22, Establishing a New Schedule of Rates and Charges for Natural Gas and Services Rendered by the Municipal Natural Gas Utility of the City of Huntingburg, Indiana. The proposed Ordinance, if adopted, will establish the following rates and charges:

Actual cost, but in no event less than \$1,000.00

Large Firm Industrial, Interruptible, Industrial Transportation:

Actual cost, but in no event less than \$1,000.00

RE-CONNECTION CHARGE (ALL CUSTOMERS):

During business hours \$ 50.00

After business hours, weekends and holidays \$ 125.00.

Deferred Payment Charge: 10% on first \$3.00. and 3% on the excess.
